The term of this License is from the moment FT licensed materials are received by the user until such materials are destroyed and all copies of such licensed materials are removed from all Licensee computers, tapes, diskettes, and other computer media.

Definitions:

“Data” is investment security prices, distributions, highs, lows, opens, market indices, ticker symbols, issue names, and other financial information regardless of how stored or redistributed. Data is collected by FT and redistributed to Licensee. This use and distribution is restricted under the terms of this License. Data may not be distributed, modified, updated, or appended by the Licensee except under separate agreement with FT.

“FastTrack®” is a computer program which is solely the property of FT. FastTrack® may be used only with Data.

Data License
